

STATEMENT ON PERSONAL DATA PROTECTION

In its day-to-day business activities, MARINA ATHINON ANONYMI ETAIRIA EKMETALLEUSIS TOURISTIKOU LIMENA KAI PAROCHIS YPIRESION with the distinctive title ATHENS MARINA SA uses personal data concerning natural persons (employees, customers, partners-third parties). When processing this data, ATHENS MARINA SA is subject to the provisions of the General Data Protection Regulation (GDPR) and the applicable national legislation on the protection of personal data.

The creation and implementation of the personal data protection system of ATHENS MARINA SA aims to implement appropriate technical and organizational measures to ensure:

- That all users are aware of the basic principles of data protection and comply with the personal data protection policies, procedures and best practices of ATHENS MARINA SA
- The protection of all information systems related to the protection of personal data in order to eliminate or mitigate the risks related to the theft, loss, misuse, damage, abuse or violation of these systems.
- That all users understand their own responsibilities for the correct application of the relevant legislation as well as for the protection of the confidentiality, integrity and availability of the personal data they handle.
- The continuous training-updating regarding the protection of personal data of the staff of ATHENS MARINA S.A.
- The continuous improvement regarding the protection of personal data of employees, customers and third-party partners.
- The monitoring, investigation and remediation of any actual or suspected incidents of personal data breaches.
- That ATHENS MARINA SA. is protected from any type of damage from the incorrect application of the legislative framework for the protection of personal data.

The implementation and maintenance of the Privacy Policy of ATHENS MARINA SA and of the individual internal procedures on personal data protection is one of the main responsibilities of the Administration and its crucial task, always in collaboration with the active participation of the Data Protection Officer (DPO). In this context, ATHENS MARINA SA committed to:

- Continuously applies the relevant legislation on personal data protection.
- Checks and approves the Personal Data Protection Policy and the individual relevant internal procedures.
- Ensures the implementation of this policy and its requirements in the corporate process.
- Directs and supports the persons who contribute to the implementation and effectiveness of the personal data protection system.
- Actively supports administrative rules regarding personal data protection.
- Monitors the achievement of the objectives of the personal data protection system
